- 9. The tenderer shall be responsible for loading/unloading arrangements.

  - b. Forfeit the security deposit in whole or to the extent necessary to cover the loss suffered by the SHIMUL and or

- C. The tenderers are responsible to <u>pay TDS</u>, <u>Service Tax and other duties</u>, <u>Interstate/ state toll fees etc.</u> Shimul will not pay any extra cost for the transportation.

- I. The tenderer shall collect the feed bags from transport and deliver the feed bags/ store materials at its destination and shall arrange the feed bags in the manner directed by SHIMUL.
- II. After collect the feed bags from KMF cattlefeed mixing plant Shikaripura shimoga dist Karnataka the tenderer shall carry the bags directly to the destination.
- III. The tenderer shall not carry in the lorry which is being used for transporting feed bags, any goods other than entrusted to him the SHIMUL.

The tenderer/ transport bidder Shall make his own arrangements for engaging the works required for unloading and carrying out the transportation work and further agree to abide by the provisions of the contractor labour (regulations and abolition) action the matter of payments of their wages etc., and future to indemnify the SHIMUL against any claim by such workers.
- 16. The cost of feed lost or damaged pilfered during transport and or the cost of feed not delivered at the destination shall have to be borne by the contractor. The ultimate authority to assess the any accident while carrying the loading unloading and arranging feed the entire responsibility regarding and third party risks and liabilities shall be that of the contractor and the SHIMUL shall automatically absolved of the Same.

- 17. The delivery vehicle should be provided by closed tarpaulins, when they would carry feed. The vehicle have a minimum adequate space of 15 X 6.5 ft and have in a capacity of minimum of 10 tons. The vehicle shall be clean and road worthy condition the contractor shall produce the relevant certificate regarding road worthiness of vehicle issued by RTO as and when demanded by SHIMUL.
- 18. There is no provision for transfer of cattle feed transportation of tender. Those who are having minimum 5 vehicles of 10/16 MT capacity can only apply for the tender
- 19. The tenderer shall ensure that all the certificate and involve require for the liable and drivers under the motor vehicle act or other enactments and rules make here under and as prescribed by the Road transport authorities are up to date and are in proper order. The contractor shall alone be responsible for the losses that SHIMUL may be suffered owing to determination of vehicle by the RTO the extent of the losses be assessed by the SHIMUL and its decision there on shall be final and binding on tenderer.
- 20. In any case of any dispute between the tenderer and SHIMUL decision of the SHIMUL shall be final and binding.

The tenderer shall be responsible to see that all certificate and license required under motor vehicle act or any other enactment and or runs there under are made available for inspection by the concerned authorities and see that any instructions given the said authorities are duly compiled with.

- 25. The tenderer shall not claim any compensation for any damage that the lorry may suffer in rates. Civil commission strikes whether within the premises of SHIMUL or outside the said premises.
